Policy – Senate Bill (SB) 848 Health Occupations - Physician Assistants - Dispensing Authority

The Board expressed concerns that the bill allowed physician assistants (PAs) to dispense independently of their supervising physician. The Board agreed to support the bill only if there were amendments in place that did not allow PAs to practice outside the scope of the supervising physician. The Board did not believe that the location restrictions proposed in the bill were necessary if the above amendments were implemented.

SB 848 is scheduled for a hearing on March 9, 2017. House Bill 1124 regarding dispensing by PAs, is scheduled for a hearing on March 8, 2017.

Board Counsel's Report

Dr. Michael Basco v. Board of Physicians, Circuit Court of Charles County, Case No. 08-C-16-000225; Board Case No. 2014-0045

At the February 8, 2017, Panel A meeting, Board counsel reported on the case involving Dr. Michael Basco's suspension for sexual misconduct and unprofessional conduct in the practice of medicine.

Since the Board Counsel report on February 8, 2017, Board counsel received the written opinion of the Court, which also held that Panel B properly considered Dr. Basco's disciplinary history when deciding the appropriate sanction. According to the Court, the Panel considered the physician's prior discipline only for sanctioning purposes and not to prove his culpability of the underlying claims, the Board's own regulations permitted the introduction of the prior disciplinary history, and there was no undue prejudice in doing so.
