Ms. Wright informed the Committee that several members' terms will end in June 2017, including the Chair's and one consumer member. Therefore, the Committee needs to elect a new Committee Chair by the July 2017 meeting.

Ms. Smith asked that current members refer potential consumer member candidates to the Committee, since consumer members are difficult to recruit.

Ms. Smith also stated that Board staff will send out an e-mail blast to licensed health practitioners soliciting candidates for the other vacancies.

Financial Disclosure Requirements for Allied Health Committee members

Ms. Wright asked that all Committee members complete the Financial Disclosure statements prior to the April 30, 2017 deadline. She also informed the Committee that Termination Disclosures are required for members whose term expires in June 2017. Mrs. Wright indicated that if the Committee members need assistance completing the disclosures statements, committee members should contact the State Ethics Commission.

Criminal History Records Checks

Mr. Bailey expressed concern that the Board is requiring athletic trainers to obtain criminal history records checks (CHRC) in addition to the CHRC's required by their employers. He emphasized the concern with multiple fees associated with having to obtain multiple CHRC's. Board staff and Board Counsel informed Mr. Bailey that the statute requires that all practitioners licensed by the Boards obtain CHRC's independent of those required by other entities.
