CHAIR’S CALL TO ORDER/CHAIR REPORT/EXECUTIVE COMMITTEE REPORT -

Noting a quorum of the Board Dr. Andrea Mathias, Chair called the meeting to order at 3:35 p.m. Dr. Mathias reported that the Board has appointed four new Board members: Suresh C. Gupta, M.D. (Internal Medicine), Gary J. Della’Zanna, D.O. (Osteopathic Surgeon), Robert P. Roca, M.D. (Psychiatry), and Alexis John Carras, M.D. (Anesthesiologist). The Board is still in need one Board member in the Consumer category and one Board member in the Public category.

The Board is in the process of developing a plan in consultation with Board staff, the Attorney General’s office, and Board members to get an accounting of the resources and the processes that it will take for the Board to transition to a two-panel system. The Board is in the process of gathering information and updating job descriptions as related to recruitment for a new Executive Director.

EXECUTIVE DIRECTOR'S REPORT - Christine Farrelly, Interim Executive Director, reported that the executive staff has been actively working with staff regarding human resource issues. The Office of Human Resources held two training sessions on human resource issues and office procedures. The executive staff is meeting with the Office of Human Resources on a weekly basis to address personnel issues. All members of board staff are receiving updated state job descriptions (MS22) to ensure performance evaluations are objective and based on current job responsibilities. The computer system upgrades are back on track. The Board is in the process of a scheduled fiscal audit conducted by the Department of Legislative Services. There may be a few findings of deficiency. Staff is taking steps to resolve these issue before the official audit report is released. The Board is in contractual modification with the vendor for peer review (Permedion) and the vendor for rehabilitation program (Maryland Physician's Rehabilitation Program).

POLICY- Wynee Hawk presented set of regulation related to Information Sharing, passed in 2011 (HB 600) and modified in 2012 (HB 1140/SB 749), for the Boards approval.

On a motion made by Dr. O'Herlihy and seconded by Dr. Suresh C. Gupta, the Board voted unanimously to **ACCEPT** the Information Sharing regulation as drafted.

Wynee Hawk reported update on the status of the Perfusionist regulation. The Board suggested that the descriptive language of item #7 in the proposed regulation publication form be changed from "hardship" to "disclosure". Wynee provided the Board with update on the status of the interim studies for certified profession midwives. The certified profession midwives workgroup held four meetings. No consensus has been met. The certified nurse midwives have met to eliminate the collaborative plan in regulation.

Mark Woodward presented the objective criteria that exist in Florida and Virginia. The Board has been asked to review and provide feedback on criteria for consideration of future allied health groups seeking licensure.
