Mr. Perez called the meeting to order at 10:01 a.m.

APPROVAL OF MINUTES

On a motion made by Mr. Sataloff and seconded by Dr. Lee-Pow, the Committee approved the March 9, 2021, Open Meeting Minutes.

LEGISLATION, REGULATIONS, AND POLICY UPDATES

Mr. Dudzic informed the Committee there were two bills introduced at the 2022 legislative session that would have had a potential impact on athletic trainers, the Board's General Provisions bill and the Athletic Trainers' Dry Needling bill. However, neither bill passed.

In response to Dr. Wilkens's question regarding whether or not the Elijah Gorham bill passed, Mr. Dudzic informed the Committee that House Bill 836, the Elijah Gorham Act had passed and been signed into law and directed them to the bill text for more information. Mr. Dudzic clarified that while the bill established policies and guidelines for operation and use of an automated external defibrillator, it did not present new requirements specific to licensed athletic trainers or the Board.
