ANNUAL REVIEW OF THE NATUROPATHIC FORMULARY

Dr. Marrongelli opened discussion about reviewing the formulary. Mr. Finkler noted that there was no legislation on this subject introduced in the 2018 Maryland General Assembly session, so the law has not changed.
